After Calgary, the urge to be home again after 5 weeks on the road got to be too great to continue on to Vancouver and Victoria where I had been to many times before anyway. I did attempt to visit Lake Louise outside Calgary but was frustrated with trying. It is just too popular during the summer. The government has put in parking lots miles out from the lake and takes tourists to the lake on buses. However, the demand far exceeds the capacity of the buses to get people back and forth. The line for the bus wrapped around the parking lot and was a 2 to 3 hour wait.

While Canada is inexpensive for Americans to visit because of the current favorable exchange rate for the American dollar, there are some things to know before you go. Your phone will probably work in Canada but it will cost you a fortune to use it. If you normally use your phone to navigate, you can rack up data charges because everything you do is roaming. It may be possible to get an International plan from your carrier, but AT&T was still too expensive in my opinion. Making future hotel reservations is harder if you are used to using your phone for research and making the reservation. I kept my phone off the entire time I was in Canada. You might also discover the portable GPS device you have in your glove compartment won't work in Canada. This could prompt a visit to Costco. There you will discover Canadian Costco only takes MasterCard and not Visa like in the US. You might also discover that your debit card won't work in the pumps either because it is from a foreign bank. It will work in ATMs and most service stations can swipe it inside but not Costco.

Canadian credit cards all require a pin so an American card sometimes confuses the service station clerk because their machine spits out a receipt that needs to be signed instead of prompting for a pin. The Canadian province of Manitoba had just passed a new law that required gasoline to be paid for in advance. The law doesn't allow you to just leave your credit card with the attendant. You must actually pay for an amount of gas. The law was so new that the attendants didn't know how to reprogram the amount preset in the pump to clear it if your car would not hold the entire amount of fuel. It caused lots of frustration for them as well as me.

I won't try to tell you about all of the adventure but just the first place I visited, Québec City and some of the places nearby. Québec City is in Canada's mostly French-speaking province. It originated around 1608. It is dominated by the Citadel high on a hill with fortified walls like many medieval European cities, with stone buildings and narrow streets. It was quite a hike up to get to the older part from my hotel. There is a stairway part way to the top, but I also discovered an elevator in a nearby tobacco shop. Even after the elevator ride, it is still three steep blocks to the Citadel level. My first experience was noticing a bicycle shop at the top on a sloping street. A man in cycling gear was attaching a trailer to his bike out front. It seemed unusual that a bike shop would be at the top of a hill on such a steep street. I also quickly discovered that it was a Surly Bicycle dealer. These are heavy steel bikes that are revered almost like a cult by some cycling enthusiasts. I have a friend in Virginia that owns two of their popular bikes, a Karate Monkey and a Long Haul Trucker. It is

common when riding with him to hear other riders yell Surly when passing, in recognition of a fellow owner.

From the top where the Citadel is located are magnificent views of the Saint Lawrence River and the Château Frontenac Hotel. The Citadel has a great tour on the changing of the guards which happens frequently. Below in the Petite Champlain district, the narrow cobblestone streets are lined with bistros and boutiques. The people manning these establishments are very friendly and all speak English as well as French. My T-shirt drawer grew astronomically during this trip.

I highly recommend a drive outside the city down both sides of the Saint Lawrence River on the ancient road known as The Chemin du Roy or road of the kings. The little towns along the road are picturesque and some contain shops and restaurants that are fun to visit. It would also be a great place for a bicycle tour

because of the quiet country nature of most of it. It is a good day trip from the city. Another place to visit outside the city is Montmorency Falls. Once you hike to the top and wander around the trails to the far side, you can see the falls across from them instead of looking straight down, you realize how close you are to the city. The tall buildings of the newer part of the city are easily visible.

I can highly recommend a visit to Canada but you should know that they are not enamored with our current U.S. President. Friends in Winnipeg inquired about my political affiliation and declared that if I was a Trump supporter they were no longer interested in being friends. I had met them in Greece years ago on a spring break tour with my children. This anti-Trump sentiment was prevalent throughout the country.

Hope you enjoyed reading my adventures in Canada.

Within a few minutes the visitor had been introduced around the room and was engaged in conversation. The apprehensive expression had disappeared as he met one nice man after the next. He had found Prime Timers.

Have you ever thought about the logo of Prime Timers with the clasped hands? With the formation of our organization and development of a symbol for us, Woody Baldwin looked for something that would be easily recognizable as a sign of welcome. The clasped hands became that symbol and we are required to have it included in every chapter's logo. And, where there are not chapters, these men are welcomed to the Independent Chapter to know about and participate in chapter, regional, and worldwide events that will welcome them from their more isolated envi-

ronments. We remain the same after 31 years as an organization offering a brotherhood of men sharing life through various social opportunities provided by chapters and the worldwide organization in most major metropolitan cities.

I recently heard a disturbing story. A man from another state visited the xyz chapter luncheon he saw on their website on calendar of events. No RSVP was required so he showed up and sat with the group. No one engaged him in conversation or introduced around the table. After some uncomfortable time, he requested a "to-go" box, took his food and left the table. He was later spotted in another part of the restaurant eating alone. Surely this could not have happened at a Prime Timer chapter event. Hopefully, it didn't for it would be in direct opposition to our founding principle of providing positive social opportuni-

ties for mature gay and bi-sexual men.

In the hypothetical chapter I described as I began this article, our apprehensive visitor may have had a different impression of Prime Timers had the men in the room continued conversations with old friends within their "clique" or if they decided he was too stuffy to be bothered with in that "straight-looking" outfit. Standing alone and unwelcomed, he may have drifted out the door he entered through thinking, I guess Prime Timers is not for me. What a shame that would have been when the man of his dreams was within the room looking for a similar dream! Happily, that smiling Prime Timer extended his hand.

Have you noticed an apprehensive stranger at your chapter's door? Be the first to extend that hand of friendship to a man who may become your very good friend.

LONG NIGHT'S JOURNEY INTO DAY

A REFLECTION



Again I find myself in Southern California visiting my mother in a skilled nursing facility. Again I am forced to confront the question of "is a long, long life of value when there is nothing left to enjoy?" It has been two years since having to move her here; she is now legally (and entirely) blind, deaf in one ear and has about 10% hearing in the other.

I've spent 5 of the 7 days here visiting her, so far. I would say it is her lifelong stubborn will that keeps her alive. Her mind is relatively clear; her concept of time is skewed. She often complains they fail to bring her her evening meal but when I continue questioning her, I often find that she has, indeed, had that meal.

Yesterday she had a lot of questions about death and convinced me that she's more than ready to end the struggle. It's been over a year

since she has been able to walk, even with a walker. Her walking consists of 2 steps from the wheelchair, a turn, and into bed. Very few people in her facility speak English. Both her roommates speak only Spanish, narrowing her interaction with the world. Basically you have someone who spent her whole life socializing, gossiping and teaching knitting and crocheting classes. Now, there is a void.

During my week in the area, I toured another facility. I like it better and all the patients speak English. The downside: if I can get her in, there is an eight-month waiting list. At this age, does she have eight months?

I observed the patients in this facility; while they seemed well taken care of, it was the same existence. We are living much longer, thanks to modern medicine. I ponder the question: is this a good thing and why? The medical community along with government and religion

have banded together to keep us alive. Our founder, Woody Baldwin, was condemned to this life until he passed. He found many of the other patients horribly homophobic, so for us this compounds the issue. He was forced to live his last day back inside the closet. When CBS News contacted me wanting to do an interview with both of us, Woody refused because it would 'out' him. This compounds the

problem of living a long life.

Along with myself, I urge all of you to work at keeping yourselves healthy, alive, and immersed in life as long as you possibly can. I've taken to wearing 'germ masks' and taking megadoses of vitamins when I fly. Stay well and stay at home as long as you can and be happy. Being part of and immersed in Prime Timers is a very big step in that direction.

HELPING HANDS

The group was called "Helping Hands". After trying to get an assistance program of this kind going in our Sarasota chapter way back when, I named it 'Helping Hands' based on the handshake logo of Prime Timers Sarasota and Prime Timers Worldwide! It was decided that at first the group of volunteer members would shop, furnish rides, and help with household chores for those who were incapacitated or possibly needing help with their partners.

This actually started in the Sarasota Chapter in 2012. It has since been revised and re-worked. It worked well when needed. I also introduced the concept to chapters when I traveled and visited with them. Over time, it started in several chapters with mixed results. In kicking it off, a notice needs to be emailed to all members to get their names on a list of volunteers for this phase. It is something that each of us needs at some point, as we continue to age.

Several years later we had a few cases of members who lived alone and had been ill or had passed away. Initially we took the entire

list of members and paired each up with someone they might not know too well and each would put in a quick telephone call each morning to the next, briefly stating 'good morning' and just asking how they were and if they needed anything. It met with mixed results.

Not everyone participated in the second part because those with partners had someone to look in on them. However, it was quite successful for those living alone. It's something that took only a few minutes. Members reported that they really looked forward to their calls each morning.

When I left the chapter as President in 2006 I turned over the files to my successor. I'm hoping the above information is enough to give you a picture of how to go about it. Recently, newer revised versions have been showing up in chapters. I now invite those chapters to contact me, when reading this article. I hope they will allow me to include their information with my information. Tell me what worked and what did not work, so that together we can create a framework to pass on.





TITLE TO REAL ESTATE

In private practice, Jim's areas of concentration have been securities, commodity futures, real estate, tax, wills and trusts.

When a client purchases real estate, I am often asked what is the best way for him or her to take title. As I find myself often saying to clients, "it depends". Below are some issues you should consider when taking title to a property you are purchasing. Of course, you should discuss the options with your attorney and determine what is best for you.

1. In Your Own Name. This is certainly an option. So, for example, title may be vested in the

name of John Smith or Jane Doe, assuming you are John or Jane. If you are not John or Jane, you can still take title in most states in the name of John Smith or Jane Doe but you may need to file a fictitious name registration stating your real name and the name you want to use. Many lenders require you to take title in your own name. However, as more fully stated below, this may not be your best alternative.

2. Purchasing with someone else. If you purchase a property with your partner or a relative, he or she may wish to be on the title with you. Assuming that, several variations,


all with different legal consequences exist:

a) Tenancy in Common - This is where John Smith and Jane Doe take title together but state that if one deceases, then their interest goes to their heirs and not to the other. In other words, there is no right of survivorship interest to Jane if John passes. So, if John predeceases Jane, then his interest in the property goes to according to his will and not necessarily to Jane. If John does not have a will then it

will go to his heirs. If Jane is not one of his heirs then Jane might have some concerns. Also, As discussed below, this concern can usually be taken care of with proper planning by your attorney.

b) Joint Tenancy - Again, this is where John and Jane buy the property together but instead of it going to the deceased's heirs or through his will, it goes to the other person automatically upon death of the first owner. So, again, if John passes before Jane, it passes immediately to Jane upon John's death and does not go through any will he has executed.

Many of my LGBT clients often prefer this way of titling property purchased by them together. This way, they are protecting each other in the event of death. Again, an attorney should help you with this to make sure both of your wishes are followed. One major caveat here, John's interest in his property are subject to the claims of his creditors. So if John has a \$100,000 judgment against him, his creditors can execute on it any time before his death and, possibly even cause the property to be sold to satisfy the judgment.

c) Tenancy by the Entirety - In a small minority of states, where John and Jane are married (or two men are married), then the property can be titled as Tenants by the Entirety. This is a special kind of Joint Tenancy for married couples. If John and Jane are husband and wife, and their property is held in Tenancy by the Entirety, then upon John's passing, it goes to Jane as in Joint Tenancy. However, the property is not subject to the claims of John's creditors unless Jane predeceases John. In other words, presume John has a \$100,000 judgment against him. If John passes before Jane, the property goes to Jane and the judgment is extinguished. If Jane predeceases John, then the judgment is not extin-

guished and John's creditor can go after the property.

3. Trust. Most often, the property will be held in a revocable trust. The Trust document will state to him the property goes to (or at least John's portion). This method of titling has nothing to do with creditors or inheritance tax or otherwise but is simply an Estate Planning device.

4. Corporation Partnership or LLC - Many times, property is held in the name of a corporation or LLC. This is invariably for business reasons. To be sure, many businesses own the property where their offices are located. Indeed, lenders who supply loans or capital may want the real estate titled certain ways. Consultation with your attorney will determine what is best for you and your business. Significant income tax consequences result by whichever method you use to take title so it is strongly recommended that you discuss this with not only your attorney but your accountant as well.

In summation, there is no "one size fits all" on how to title real estate. Business and personal considerations come into play when making those decisions. What is set forth above are some general guidelines to consider when making those decisions. Good luck.

Halloween Fun Facts

1. Halloween, or All Hallows' Eve, can be traced back about 2,000 years to a pre-Christian Celtic festival held around November 1 called Samhain (pronounced "sah-win") or "summer's end" in Gaelic.
2. Dressing up in costumes was once a way to hide from ghosts. The tradition started as a way for the Celtic and other European people to hide from the spirits who returned at this time of year. People wore masks when they left their homes after dark so the ghosts would think they were fellow spirits. To keep the ghosts out of their houses, people would place bowls of food outside to make them happy.
3. Jack-o'-lanterns were originally carved into turnips. In a traditional Celtic story, a man named Jack tricked the Devil, so after Jack died, the Devil made him roam the night with only a burning coal to light his way. Jack put the piece of coal in a carved-out turnip, a common vegetable then, and thus it became known as Jack of the Lantern. Irish and Scottish people would carve their own versions of Jack's lantern with scary faces and place them near windows or doors to frighten away Jack or other evil spirits. When immigrants brought the tradition to America, the native pumpkin was more available than turnips, giving rise to today's jack-o'-lanterns.
4. Trick-or-treating likely evolved from the medieval custom of "souling" in England. On All Souls' Day celebrations during November 2, poor people would knock on doors asking for food in exchange for saying prayers for the home's dead relatives.
5. Cats have been part of the history of Halloween for centuries. During Samhain, priests used cats as part of a ritual to try to predict the future.
6. The "bon" in bonfire is a reference to bones. During Samhain, priests lit large fires to represent the sun returning after the hard winter. They would throw the bones of cattle into the flames, creating a "bone fire".
7. Black and orange are the traditional colors used for Halloween decorations. Orange is seen throughout autumn's changing leaves and is a symbol of strength and endurance, while black is typically the color of death. The Celts may have been the first people to use this color combination to gain strength for the long winter ahead and celebrate the dead during the Samhain holiday.
