

PTWW Business Meeting Overview



General Business

For the first time in years, Chapter Presidents will vote on approving the twoyear budget of PTWW. The financial reports and budget will be mailed to Chapter Presidents in September.

The \$2/member fee is automatically restored, after the one-year reduction to \$1/member during the 2020 pandemic which impacted Local Chapters' finances.

Bylaws Changes

The Board proposes two changes, with the first allowing a Local Chapter to design a logo without a handshake. The second proposal specifies that a video conference is a valid meeting for the Board.

Board Elections

The 5-person Nominating Committee received only eight (8) candidates and unanimously approved candidates for the nine (9) Board positions. There are no contested elections this term, so a vote of acclamation will be conducted for the eight unopposed **candidates listed on pages 4-5**. As there is no candidate for Treasurer, the new Board will appoint a qualified Prime Timer later this year to fill the vacancy. Vancouver / Bowen Island Day Trip



10th Anniversary of the "Don't Ask, Don't Tell" Repeal

The tenth anniversary of a very important event for LBGTQ Americans is coming up. On September 20, 2011, at 12:01 a.m., President Barack made a major Congress, from both parties, who voted for repeal; to our civilian and military leaders who ensured a smooth transition; and to the professionalism of our men and

*announcement regarding the repeal of the "Don't Ask, Don't Tell" (DADT) policy established during the Clinton Administration.

Earlier, President Obama had signed the repeal into law in December of 2010, and in July of 2011 the President, the Secretary of Defense, and the Chairman of the Joint Chiefs of Staff certified that the



women in uniform who showed that they were ready to move forward together, as one team, to meet the missions we ask of them."

Prior to the repeal of the DADT policy, our military employed what was a by-andlarge homophobic policy. History tells us, through various research efforts by advocates for LGBT veterans, that roughly 114,000 U.S. service

Department of Defense had taken all the steps needed to prepare the military for repeal. Sixty days after that, at 12:01 a.m. on September 20, 2011, the era of DADT was over.

"Patriotic Americans in uniform will no longer have to lie about who they are in order to serve the country they love," the President said in a statement that day. "Our armed forces will no longer lose the extraordinary skills and combat experience of so many gay and lesbian service members."

The President called the achievement "a tribute to all the patriots who fought and marched for change; to Members of

members were "involuntarily separated" from the military due to their sexual orientation between the end of World War II and the repeal in 2011 of the DADT policy that barred LGBT people from serving openly in the military.

This history also shows that during WWII, when America needed every able bodied man and woman it could muster, homosexuality was largely overlooked when discovered within the ranks. But at the end of the war, when America needed to reduce its military ranks, the number of less-than-honorable discharges expanded exponentially. The largest number of these was handed to folks that were identified as

homosexuals, though the tactic was also use to remove many non-white from the rank and file. The idea that this same type of action against homosexuals also took place at the time of America's withdrawal from the Vietnamese conflict is also largely supported. During the DADT period of our military's history, some 1,200 officers were removed from the ranks for failing to hide their sexuality.

Having received a less-than-honorable discharge not only meant a forced dismissal for service, it meant that the veteran, even those that had received honors for valor or for being wounded, would not be eligible for Veteran's Services (medical, housing, education, etc.). For many, it meant being unable to find anything other than minimal employment.

This date, September 20, might best be marked and lifted in two separate but equal manners. First, for all LBGTQ Americans and their supporters, it is and will remain our day of liberation, at least

until the day that will come when Federal law includes sexual orientation as an integral part of the protections now provided in the 14th Constitutional Amendment

Second, we should take the time to salute all LGBTQ military members, especially those (1) that served under the additional duress of potentially being exposed, (2) that were given a "less-than-honorable" discharge and therefore a disrupted life because of their sexuality, (3) who successfully hid the fact that they are or once were associated with the LBGTQ community, (4) that returned to stateside unscathed by their sexuality, only to lose their employment due to the Eisenhower Executive Order that banned homosexuals in Federal Government jobs (many states followed suit), and (5) that especially made the ultimate sacrifice for our greater good.


